

Board of Trustees Meeting Summary January 22, 2014

Appointment of Interim President of Metropolitan State University

The Board of Trustees, upon the recommendation of Chancellor Steven Rosenstone, appointed Devinder Malhotra as interim president of Metropolitan State University effective July 1, 2014, subject to the completion of an employment agreement. The board authorized the chancellor, in consultation with the chair of the board and the chair of the Human Resources Committee, to negotiate and execute an employment agreement in accordance with the terms and conditions of the MnSCU Personnel Plan for Administrators.

Appointment of Vice Chancellor of Information Technology/Chief Information

The Board of Trustees, upon the recommendation of Chancellor Steven Rosenstone, appointed Ramon Padilla, Jr. as vice chancellor for information technology/chief information officer effective February 18, 2014, subject to the completion of an employment agreement. The board authorized the chancellor, in consultation with the chair of the board and the chair of the Human Resources Committee, to negotiate and execute an employment agreement in accordance with the terms and conditions of the MnSCU Personnel Plan for Administrators.
